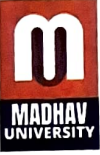
S.No.	Points for prohibition of Ragging	Measures to be taken/being taken to curb the menace of Ragging.
1.	Common party of the old and new students	It was resolved that all the Deans and Heads should take steps to hold for a party so that students may have introduction of each other.
2.	Anti-Ragging Squad	All the Deans and Heads of the Faculties and the Departments have been requested to constitute the anti-ragging squads consisting of teachers/non-teacher to put on vigilance duty at all sensitive points like, entrance points, hostels, canteens, libraries, play grounds, out-side the class rooms in the corridors etc. and all common facilities. The squads will reach at these points prior 30 minutes and leave after 30 minutes after the closing of the classes.
3.	The concept of mentor-mentee.	The concept of mentor-mentee, the Heads of the Departments were requested to adhere to this concept .
4.	Orientation/Get to gather of the students(Old and new).	Arranged various anti-ragging activities and measures taken in the university on regular basis to curb ragging and assured that Students are safe in University. ZERO tolerance Zone for ragging and no such

		<p>activities are reported till date.</p> <p>The whole campus is instilled with banners, Notice, and Warning signs throughout the campus. An awareness meeting was held with parents, students, hostel wardens. Posters and Power Point presentations with illustrations are shown to the students indicating that the ragging committee consists of an anti-ragging squad nominated by the head of the institution</p>
5.	Regulations of the Regulatory Councils	The Faculty Deans were requested to adhere to the instructions and guidelines of the Regulatory Councils so that extreme ragging and suicide cases may not occur.
6.	UGC developed 05 TV commercials of 30 seconds each.	The Deans were requested to introduce UGC developed 05 TV commercials of 30 seconds video anti ragging campaigning, anti-ragging poster, anti-ragging competition for student / faculty/ general awareness of the menace of the ragging, with different perspective for parents, victim and Offenders
7.	UGC Posters	UGC designed and distributed 04 types of posters amongst Universities have been displayed at required places.
8.	Affidavits	University is implementing the procedure for students and their parents at the time of admission.
9.	Display of e-mail address of Nodal Officer	e-mail address of Nodal Officer of the Anti-ragging committee has been displayed at all common places.
