1	Constitution of Anti	Anti Ragging Committee as per UGC regulations- 2009 has been constituted which will work for prevention of the menace of Ragging in the University.

2.	Anti-Ragging Squad	All the Deans and Heads of the Faculties and the Departments have been requested to constitute the anti-ragging squads consisting of teachers/non-teacher to put on vigilance duty at all sensitive points like, entrance points, hostels, canteens, libraries, play grounds, out-side the class rooms in the corridors etc. and all common facilities. The squads will reach at these points prior 30 minutes and leave after 30 minutes after the closing of the classes.
3.	The concept of mentor-mentee.	The concept of mentor-mentee, the Heads of the Departments have already been made aware about it.
4.	Orientation/Get to gather of the students (Old and new).	Arranged various anti-ragging activities and measures taken in the university on regular basis to curb ragging and assured that Students are safe in University. ZERO tolerance Zone for ragging and no such activities are reported till date. The whole campus is instilled with banners, Notice, and Warning signs throughout the campus. An awareness meeting was held with parents, students, hostel wardens. Posters and Power Point presentations with illustrations are shown to the students indicating that the ragging committee consists of an anti-ragging squad nominated by the head of the institution
5.	Legal Counsel	Legal Counsel is being appointed.
6.	Regulations of the Regulatory Councils	All the instructions and guidelines are being followed of the Regulatory Councils so that extreme ragging and suicide cases may not occur.
