Madhav Homoeopathic Medical College and Hospital Madhav Hills, Post -Bharja, Tehsil -Pindwara, Opp. Banas River Bridge Toll Nh-27, Abu Road, Sirohi- 307026. Rajasthan functioning since 2017, has submitted application for conducting BHMS course with intake capacity of 100 seats for the A.Y. 2024-25. The college has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rataog Board has examined the profile of the college as to whether the college fulfils the Mining im Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of Part 1, report of inspection conducted on the Medical Assessment and Rating Board has — observed following shortfall.

b). Miscellaneous

- College has not enabled the Aadhar Enabled Biometric Attendance System (AEBAS). Same may be implemented within one month of time.
- Form 16 are not uploaded. Copy of the same may be submitted within a period of one month for verification.

c) Inspection remarks

- The inspection team arrived at the college by 9:45am on visiting the LP.D ward, no patients were admitted or seen According to LP, records, there were 5 patients
- Only manual registration entries were found; no computerized records were available.
- Only one CCTV Camera was working at the entry door, which did not cover the LP.D O.P.D registration counters.
- We checked CCTV—footage of previous day & there were no patient inflow as entered in central O.P.D register
- The LP ward bathrooms show no signs of usage
- There is no clinical Lab inside the college building. The Lab shown was situated in another building, which appeared to function as an Ayurveda / Physiotherapy College under the same management. This is highly objectionable, and college should have its own laboratory. The same may be established and compliance may be sent within 30 days.
- They are maintaining Clinical Lab register, which did not show any test results

- There is an old X-RAY machine in the same building—that is not functioning. Authorities pointed out an X-RAY machine is available in the Ayurveda / Physiotherapy college in nearby building. The college should have its own X-RAY and USG equipment of its own as per provision of NCH Act 2020 and its relevant regulations. This may be implemented exclusively for Homoeopathic Medical College and compliance shall be submitted within one month.
- According to the attendance register, there are 40 teaching staff. However, only 17 were
 present on the day of the visit, and 23 were absent without proper leave applications. The
 leave applications submitted by the authorities were written & signed by the same
 person. Copy of the attendance register and signed copy of the acquittance roll of all
 faculties for past 3 months shall be sent for verification.
- According to the Hospital staff attendance register, there are 42 staff members, only 23 present & 19 were absent. The principle may provide explanation on the same
- According to the non-teaching staff attendance register, there are 15 staff members. One staff member was absent, & four staff members shown by the authorities did not have LD cards, with their signatures not matching those in the register.

Considering the above observations and facilities available, MARBH has decided to Issue Conditional Permission for functioning of Madhav Homoeopathic Medical College and Hospital Madhav Hills, Post -Bharja, Tehsil -Pindwara, Opp. Banas River Bridge Toll Nh-27, Abu Road, Sirohi- 307026, intake capacity of 60 seats reduced from 100 seats for BHMS course during A.Y. 2024-25.

All deficiencies noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made for NELT qualified candidates only. It is further informed that 100% of order radiate seats of the permated intake capacity of 60 LCs seats shall be treated as All india Quota shall be conducted by respective counselling anibority as design ited by Central Covernment for the A.Y. 2024-25.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn or denied in the subsequent year if the college is found deficient in Compliance to MSR 2013 anytime during the academic year

If the College is aggrieved with the above decision, College may place an appear to the National Commission for Homoeopathy (Assessment and Rating of Medical Institutions) Regulation 2024, section 14 sub-section (3) and NCH (General Regulations) 2023, section 22 within a period of 30 days.
