Sir/ Madam,

In reference to Medical Assessment and Rating Board for Homoeopathy (MARBH) letter No. 4-7/ MARBH/NCH/2025-26(119-10)/4301, dated: 08.07.2025 Madhav Homoeopathic Medical College and Hospital, Madhav Hills, Post-Bharja, Tehsil- Pindwara, Abu Road, Sirohi-307026 Rajasthan has filed an appeal to the commission against the decision of MARBH vide their letter no. MHMC&H/O.O./1733/2025 dated: 06.08.2025.

Commission has recommended MARBH vide letter no. 30-5/2025-26/NCH-GR (96)/5535, dated: 19.08.2025 for the continuation of permission for 60 seats for 1st BHMS course to the Madhav Homoeopathic Medical College and Hospital, Madhav Hills, Post-Bharja, Tehsil- Pindwara, Opp. Banas River Bridge Toll, NH- 27, Abu Road, Sirohi-307026 Rajasthan for the academic year 2025-26. Accordingly, MARBH is granting Conditional Permission for 60 seats for BHMS Course for the academic year 2025-26 based on the following conditions:

- i. *College will submit the compliance report for appointment of deficient teaching staff within one month failing which permission may be withdrawn for the academic year 2025-26.*
- ii. *College will implement and comply with the salary structure of teaching staff as per MES-2024 within one month failing which permission may be withdrawn for the academic year 2025-26.*


All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 60 seats of BHMS course shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government and counselling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn in the subsequent year if college is found deficient in compliance to MES-2024 anytime during the academic year.
